Domestic letters

A Mail and B Mail individual items

- Amendment to list prices across all format levels; some price reductions.
- Amendment to the product structure for the standard format: now 1–50 g (previously 1–100 g), from 51 g now midi format level (51–500 g).
- Prices up to B5 format 1–50 g now without VAT (see [factsheet “Cancellation of voluntary VAT opt-in”](#)).
- The fee for sorting by location, P.O. Box or mail carrier district will be cancelled.
- The format surcharge (thickness 20–50 mm, CHF 2.00 incl. VAT) on the standard and midi basic price will be discontinued and replaced by the “Volume letter” product.

B Mail bulk mailing, OnTime Mail and election and voting consignments

- Amendment to list prices across all format levels. Some price reductions due to the adjustment of the weight surcharge of 1 centime per 25 g (previously 1 centime per 20 g), which will now only be used for the midi and large formats.
- Amendment to the product structure for the standard format: now two price categories 1–50 g and 51–100 g.
- Prices up to B5 format 1–50 g (incl. postcard) now without VAT (see [factsheet “Cancellation of voluntary VAT opt-in”](#)).
- With “OnTime Mail on a specific working day”, delivery will no longer be possible on Mondays.
- The “OnTime Mail Saturday” service will be discontinued.

Business reply labels

- The surcharge for business reply labels will now be 20 centimes (previously 10 centimes) and will continue to be added to the prices for standard (B5) and large (B4) formats. Business reply labels will still be subject to VAT.
- For business reply labels for B Mail bulk mailings (response rate per month >350 items), the price for B Mail individual items will now apply.

Format surcharge: new volume letters

- The format surcharge for standard and midi letters over 20 mm and up to 50 mm thick for A Mail, B Mail individual items and A Mail Plus will be replaced by the new “Volume letter” product.
- The new “Volume letter” product has a barcode (beginning with 98) that enables electronic consignment tracking (similar to A Mail Plus).
- The prerequisite for use/invoicing is the use of a “Letter mail easy” franking licence.

Letter with ID check has been further developed and will be replaced by “Letter with digital ID check”. The ID document check and data extraction will now be carried out automatically during identification. The price will remain unchanged at CHF 26.00.

Discontinued: Letter with ID check and contract signing (LID-CS)

Due to low demand, the “Letter with ID check and contract signing” (LID-CS) service will be discontinued. If required, the contract and a reply envelope can be enclosed with the “Letter with digital ID check”.
